EXOR issues €250M Notes due in 2025

EXOR (rated BBB+ with negative outlook by Standard & Poor's) announces today the issue of € 250 million non-convertible Notes with final maturity date 22 December 2025 through a private placement to institutional investors.

The purpose of the issue is to raise new funds for EXOR's general corporate purposes, including the refinancing linked to the acquisition of PartnerRe Ltd.

The Notes, listed on the Regulated Market of the Luxembourg Stock Exchange, with an issue price of 98.934%, pay a fixed annual coupon of 2.875%.

This press release is not, and shall not constitute, an offer to sell or a solicitation of an offer to buy the notes, nor shall there be any sale of these securities in any state or jurisdiction in which such an offer, solicitation or sale would be unlawful or restricted by law, including the Republic of Italy. The offering of the notes has not been cleared by the Commissione Nazionale per le Società e la Borsa (CONSOB), pursuant to Italian securities legislation. Accordingly, the notes have not been and will not be offered, sold or delivered in Italy in an offer to the public.
