

## OUTSTANDING SHARE CAPITAL AND TOTAL NUMBER OF VOTING RIGHTS AT THE DATE OF THE NOTICE FOR THE 2024 ANNUAL GENERAL MEETING

On 16 April 2024 - the date of the notice for the Annual General Meeting of Shareholders (the "AGM") of Exor N.V. (the "Company") to be held on 28 May 2024 in Amsterdam, the Netherlands - the share capital of the Company consists of the following:

220,984,247 issued ordinary shares.

Ordinary shares are listed, freely transferable and each of them confers the right to cast one vote. On the date of this notice, the Company holds 5,048,767 ordinary shares and 533,325 special voting shares in treasury. No vote may be cast on shares belonging to the Company or to a subsidiary thereof or on shares in respect of which either of them holds the depositary receipts.

124,717,163 issued special voting shares.

Special voting shares are not listed, are not transferable (with the limited exceptions set forth in the Special Voting Shares Terms and Conditions) and each of them confers the right to cast four votes.

As of today, the total number of voting rights which can be cast at the AGM equals to 712,670,832.
